- **Projects:** A project for new signage in the library is complete; logo wear has been ordered for library staff; the Village of Lakeview has voted to support the DDA's agreement with the library regarding the downtown lot, and paperwork is in process; the library's tax request and budget resolution has been forwarded to all authorities.
- **Programs:** Nobel invited members of the Board to a visiting authors open house event, "Bios, Books, & Brunch" on Sept. 16 & 17, and to a library showcase in October 6 which will feature the new special use collections.

Rasmussen moved to accept the budget adjustment as submitted. Motion carried.
